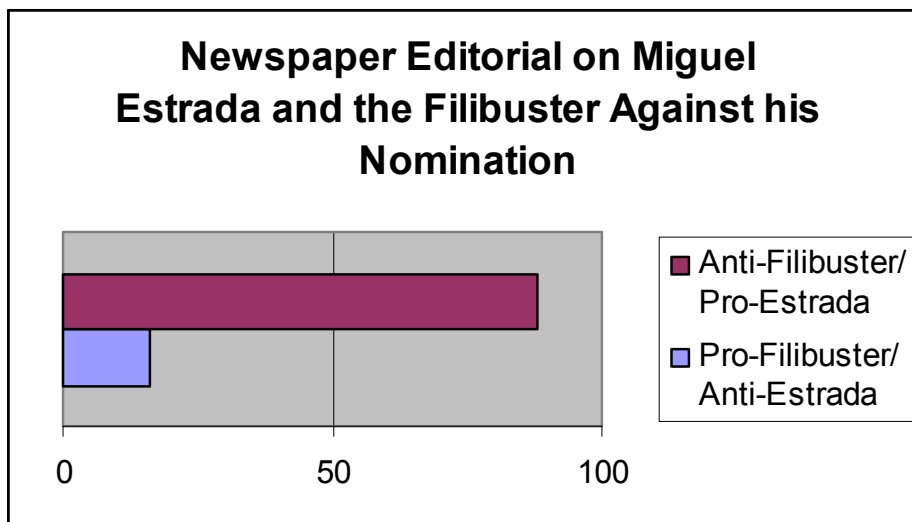
Miguel Estrada: *What the Nation's Editorial Pages Are Saying*

March 6, 2003

Senate Democrats continue to lead a filibuster against the nomination of Miguel Estrada to the U.S. Court of Appeals for the D.C. Circuit. The obstructionist maneuver is now in its fourth week, with no discernable end in sight. A handful of Senators, led by Charles Schumer (D-NY), Ted Kennedy (D-MA), Patrick Leahy (D-VT) and Tom Daschle (D-SD), parroting the talking points of Washington's most liberal special interest groups, continue to hold up the important work of the U.S. Senate as they paint Mr. Estrada as a "right-wing ideologue," while at the same time claiming they "do not know enough about him." (*Quite the contradiction.*) As a result, all 100 Senators are being denied their constitutional responsibility of voting yea-or-nay on Estrada's nomination.

While the Senate is playing politics as usual, it is clear the American people are fed up with the obstructionism. And since Mr. Estrada's nomination was voted out of committee on January 30, the nation's editorial pages (*not traditionally bastions of "right-wing ideologue" thought*) have weighed in on the battle.

While there have been numerous articles, opinion editorials and letters-to-the-editor written on this subject, the following focuses on the views expressed by the nation's newspaper editorial pages.



Since Miguel Estrada's nomination was approved by the Senate Judiciary Committee on January 30, 2003, we were able to find 104 editorials on this subject. 88 were Anti-Filibuster/Pro-Estrada while 16 were Pro-Filibuster/Anti-Estrada.
